The Chairman of the Board of Supervisors of the County of Glenn, State of California, called the duly noticed special meeting to order at 10:32 a.m., with members as follows:

1. **Public Records Act**

Matter: Hold discussion for possible action regarding letter received from the Sacramento Valley Mirror Attorney Duffy Carolan dated April 3, 2002, stating that if no decision is made regarding the information originally requested by Mr. Tim Crews on January 11, 2002, by April 5, 2002, this matter will be filed in the Superior Court of Glenn County.

Proceedings: a. County Counsel Belinda Blacketer reviewed matter and submitted a letter from Mark A. Wasser, Attorney, stating that he would represent the County in a Public Records Act action to defend a refusal to disclose confidential cellular telephone numbers;
b. County Counsel advised that all numbers could be released, except Court employees, as they are exempt from the Public Records Act;
c. Supervisor Sprague inquired why this matter was not being held in closed session since the subject was litigation; whereby County Counsel advised that they could adjourn to Closed Session but that matter has been discussed in regular session;
d. Later this date upon further discussion, it was the general consensus of the Board to place the County wide policy regarding the Public Records Act, and the Sheriff's policy regarding the Public Records Act on the April 16, 2002 agenda for possible action

Motion/Second: Supervisor Hansen/Supervisor Sprague

Order: Release all cell phone numbers in the county except for the Courts, which the County has no jurisdiction over

Vote: Unanimous.
