Chapter 060 Salaries of Department Heads & Non Represented Employees

- **Section 020 Elected Officials**
 - In January of each year, the board of supervisors shall consider adjusting the salaries and benefits of elected officials of the county. Any adjustment in the compensation of members of the board of supervisors shall be done only by ordinance. (Ord. 1043 § 1, (Part) 1994; Ord. 985 § 1, 1991; Ord. 951 § 2 (part), 1989; Ord. 823 § 2 (part), 1985.)
- **Section 021 Salary Range for Members of the Board of Supervisors**
 - As of April 10, 2006, the biweekly salary range for members of the board of supervisors of the County of Glenn shall be Range 245 with steps as follows:
 - Step A \$1,006.40
 - Step B \$1,056.80
 - Step C \$1,109.60
 - Step D \$1,164.80
 - Step E \$1,223.20
 - Each Supervisor in office on April 10, 2006, shall be placed at Step C of the range. The Chair of the board of supervisors shall receive an additional biweekly stipend of Fifty Dollars (\$50.00). (Ord. 1186 § 1, 2006.)
- **Section 022 Adjustment of Supervisors' Salaries**
 - Commencing on January 2, 2007, and on the second day of January of each year thereafter, the salary of all members of the board of supervisors shall be adjusted upward by one step on the range as established by section 3.06.021. Said salary adjustments for the supervisors shall not be effective until at least sixty (60) days after January 2, so as to comply with the provisions of Government Code section 25123.5. (Ord. 1186 § 2, 2006.)
- **Section 023 Salary Upon Election of Supervisors**
 - Upon taking office, newly elected Supervisors shall be placed on the same Step as the defeated

incumbent. (Ord. 1186 § 3, 2006.)

Section 024 Salary Upon Election of Department Heads

- Upon taking office, newly elected department heads shall be placed on the same Step as the defeated incumbent or on Step A if no incumbent was involved in the election. (Ord. 1186 § 4, 2006.)

Section 030 Appointed Department Heads

- In January of each year the board of supervisors shall consider adjusting the salaries and benefits of appointed department heads. (Ord. 1043 § 2, (Part) 1994; Ord. 985 § 2, 1991; Ord. 951 § 2 (part), 1989; Ord. 823 § 2 (part), 1985.)

Section 040 Non-represented Employees

- Each year the board of supervisors, by resolution, may adjust the salaries and benefits of all employees of the county not represented by an established bargaining unit. The adjustment may be made pursuant to recommendations by the director of personnel. (Ord. 951 § 2 (part), 1989; Ord. 840 § 1, 1985; Ord. 823 § 2 (part), 1985.)
