5. Discussion Items

Matter **a**: Budget/Staff Report

Documents: Auditor Cash Balance Report, period ending 4/5/2022. Proceedings: Talia Richardson reported cash in treasury of \$678,588.18.

Member Pieper inquired on COVID related grants and what they were for. Mrs. Richardson replied they covered loss of fuel sales and site worker expenses.

Member Peavy inquired why we were over on "Professional" budget.

Alex Galvan explained it was due to the required trimming of the trees next to the Pilot's Lounge at 037. Mr. Galvan further reported the beacon light at WLW had to be replaced for the second time since November. Road crew sprayed for weed abatement at both airports. Mowing was done and the Hurlburt's just cut hay and will be cleaning up. Fuel prices are on the rise. Continue to work on weed issue on the tarmac, road sprayed and Mr. Galvan is using a shovel. Mr. Galvan also directed the City Sweeper to stay off asphalt to preserve integrity.

Member Kraemer commented regarding the beacon at WLW, possibly check transformer for voltage; may need to be replaced. Member Peavy added we may want to move to LED.

Member Peavy inquired on the weed issue at 037. Mrs. Richardson reported she had a meeting with Ag Department as to what is needed to spray and when. We have the equipment but, there is an issue with product availability. A road employee has been placed in charge to handle airports specifically and will communicate with Ag. Mr. Galvan shared that the Michauds have offered to assist if needed.

Mr. Galvan updated there are no vacancies at 037 and there are 5 vacancies at WLW. Member Peavy inquired how many are unusable. Mr. Galvan reported only hangar 9 has door issues currently.

Member Pieper reported his hangar door is sagging and rubbing. Mrs. Richardson stated Alex will get with Facilities to repair. Member Kraemer inquired who is responsible for door/header issues if aircraft is damaged. Scott DeMoss, CAO, replied County Counsel has addressed this in the

lease. Member Lely commented that it states the plane owner is responsible. Mr. Rust added it depends on which lease you have. Mrs. Richardson pulled up the current lease to see verbiage and reviewed with committee. Member Pieper asked, "Shouldn't the Landlord be responsible?". Mr. DeMoss replied the hangars belong to the Airports, not the County. Member Lely requested staff look into what exactly the County insurance covers. Mr. DeMoss replied he would look into this with County Counsel, specifically "structural" issues.
