#### 3. Staff Report

Matter: Willows Memorial Hall HVAC

Proceedings: Di Aulabaugh shared a photo of the HVAC unit for WMH that failed and

reported the repair was complete.

#### 4. **Projects**

Matter: a. Replacement of HVAC units at HHSA N. Villa Ave. Site

Documents: None

Proceeding: Ricardo Valdez reported HHSA has requested to upgrade their HVAC

units. There are 6 units, 5 are more than 27 years old with the  $6^{th}$  unit being 8 years old. To date two estimates with replacement costs have been received and range from \$7300 - \$7700 each. Waiting on additional vendor estimates to determine best price. Seeking approval

from Committee to proceed with replacement funded by HHSA.

Matter: b. Courthouse Project

Proceeding: Matt Gomes reported County has completed its part. Projected actual

move for Court is March with start date of underground utility in

projected in Spring.

Matter: c. Jail Expansion

Proceeding: Sheriff Warren reported funding of Jail Expansion project was not

sought in this round due to cash flow and lack of guaranteed timely reimbursement. Also shared that they are looking to refurbish jail and add annex for classroom and medical space. Currently has no dental services space and inmates have to be transported. Governor has approved \$250 million Lease Revenue Bond that requires County responsibility for up front funding followed by reimbursement from state. Once bond process is over, County can obtain building back.

Matter: d. Parking Plan

Proceeding: Dwight Foltz reported parking alternative is to remove portion of grass

and tree(s) from west side of Memorial Hall. Also adding additional spaces on Sycamore. The number of spaces being eliminated due to

construction process is approximately 25-30.

Matter: e. Campus Phone System

Proceeding: Ricardo Valdez reported portion of upgrade to CAT5E or better was

completed last weekend. Anywhere requiring upgrade was brought up to CAT6. Erin Valdez reported working on call flow for HHSA. Linda Durrer inquired of target date. Di Aulabaugh responded it was delayed by a few weeks and all would follow the installation at HHSA due to size and complexity of the agency. Questions were raised regarding

features and other related installation and discussion ensued.

Matter: f. Child Support-PG&E

Proceeding: Di Aulabaugh reported that Facilities provided estimates for the

installation of separate metered service to the Child Support building.

There are no plans to pursue at this time.
