Proceeding: Di Aulabaugh introduced Sally Senestraro of Bayliss Library whom

introduced Wallis Cramer, Bayliss Friends of the Library Committee, and Jody Meza, Willows Public Librarian. Mrs. Senestraro shared a list of goals, improvements, and requests related to the preparation of the Bayliss Library grounds for their upcoming centennial celebration.

Mrs. Senestraro informed the committee that all the improvements would be done by community volunteers. Their goal to keep future maintenance of improved grounds minimal. Mr. Cramer assured the committee that all improvements will be ADA compliant. Jody Meza reported they have seen an increase of visitors and materials checked out at the Bayliss Library of nearly double in the last couple years and she fully supports the improvements.

Sheryl Thur inquired what would need to go to the Board of Supervisors. Mrs. Aulabaugh replied recommendation that the Friends of the Library were looking for a waiver of any applicable County Permit Fees and permission to make improvements at this County property.

Mrs. Thur inquired where these records, needing climate control, were going to go if the connector was demolished. Mrs. Aulabaugh suggested the special meeting to discuss this matter and

members agreed to do so on May 5 or 9, 2016.
