- b. Ms. Chavez-Cardona reported she was able to negotiate a three-year contract with LexisNexis which honored the competitor's quote and lowered the monthly payments.
- c. Ms. Chavez-Cardona reported Doug Ross, Contributing Editor of the Sacramento Valley Mirror interviewed her for an article that was published on December 7, 2022, which shared with its readers where the Law Library was located. What resources are available for online legal research, which are currently offered through LexisNexis. The progress and benefit of having M&I create shortcuts to the Court's website, Judicial Council, so the public can have access to court forms and filing information.
- d. Ms. Chavez-Cardona reported she had opened a ticket with Matson & Isom so IT staff could reinstall the printer, create shortcuts to the Superior Court's website, Judicial Council so the public has the ability to fill out and print out their forms, and research filing instructions under the Self-Help tab. A shortcut to the Sacramento Law Library so the public can have additional legal resources.
