## **New Tobacco Laws for 2016**

#### On May 4th, Governor Jerry Brown signed 5 tobacco-related laws which were enacted on June 9th!

**Tobacco Products Minimum Legal Age, SB 7 X2 (Hernandez-D, Azusa**): This law increases the age of sale for tobacco products to 21. Every person, firm, or corporation that knowingly sells, gives, or in any way furnishes to another person who is under 21 years of age, any tobacco product or paraphernalia that is designed for the smoking or ingestion of tobacco, is subject to either a criminal action misdemeanor or a civil action.

**Electronic Cigarettes, SB 5 X2 (Leno- D, San Francisco):** This law adds electronic devices (such as electronic cigarettes, that deliver nicotine or other vaporized liquids) to the existing tobacco products definition, and make furnishing the tobacco product to a minor a misdemeanor.

**Smoking in the Workplace, AB 7 X2 (Stone- D, Scotts Valley):** This law prohibits smoking of tobacco products inside an enclosed space, at a place of employment. This bill closes the loopholes in smoke-free workplace laws, including hotel lobbies, small businesses, and break rooms.

**Tobacco Use Programs, AB 9 X2 (Thurmond– D, Richmond):** This law requires the State Department of Education to require that all school districts, charter schools, and county offices of education receiving funding under the tobacco use prevention program to adopt and enforce a tobacco-free campus policy prohibiting the use of tobacco and nicotine products in a county office of education, charter school or school district-owned or leased building, on school or district property, and in school or district vehicles without regard to whether those entities receive funding.

**Cigarette & Tobacco Product Licensing: Fees & Funding, AB 11 X2 (Nazarian– D, Sherman Oaks):** This law establishes an annual Board of Equalization tobacco licensing fee for retailers of cigarettes and tobacco products for each retail location. Inside this issue:

#### On May 10th, City of Willows adopted a tobacco-related ordinance

The City of Willows now has an outdoor comprehensive smoke-free ordinance, which prohibits smoking and vaping 20 feet from any business entryway and at any common area at a shopping mall, playground, recreation area, or service area (like a bus stop).
