Member Weinrich contacted property owners next to Willows Cemetery, the Knowles, to clean out ditch before Fall; ditch is 30% plugged. He also spoke with GCID regarding siphon leak found under Willows Cemetery canal. GCID holding off on repair. City of Willows is sending out their Vac truck to suck out all pump stations for us. Member Hinton inquired on the size of the pipe leaking under the canal. Mr. Miller stated he wasn't sure but, probably a 5 or 6 foot.
- Status of Retention Basin Road Grade –
  Grading and clean out of basin complete.

#### c. Status of Mobile Pump –

Rental pump has been returned a month early to save cost. Chair Murray inquired on rental cost of pump. Mr. Miller replied \$2300 per month, we had for two months.
