Monthly Project Updates

- County phone system support is ongoing for GCSO and Probation
 Antivirus upgrade and migration is in progress and going through testing
- Document Imaging Solution (Laserfiche) is currently under support with ECS for the conversion and migration of both HHSA and PPWA files
- Research is ongoing for the proper solution to replace Spector for departments outside of HHSA
 - Looking at ASA or Ironport as viable options
- VMware vCloud has been sized and quoted for offsite disaster recovery
 - Currently waiting for final projects to be completed before proceeding
- Discussions are ongoing to move HPUX to the Finance back office prior to server room rewire in the late spring
 - Need to confirm power options in Finance back office
 - Need to clean Finance back office (per Ed) prior to move
