HIGHLIGHTING AB 935

On October 7th, 2023, California Assembly Bill 935 (AB 935) was signed into law with the aim at clarifying the enforcement of illegal commercial tobacco sales. It will take effect on January 1, 2024.

AB 935 addresses some of the implementation concerns of SB 793 (flavored tobacco ban). The enforcement process will align to the STAKE Act which also addresses the illegal sales of tobacco to underage individuals. AB 935 will allow the state licensing board to suspend or revoke state-issued licenses for retailers who have violated the flavor ban 3 or more times.

AB 935 also helps expand the definition of a tobacco retail location. The bill defines a tobacco retail location as, "a building from which tobacco products are sold at retail, and includes vending machines, vehicles, mobile units, booths, stands, and concessions that conduct in-person sales of tobacco products directly to the public."

The bill also mentions that the CA Department of Public Health is the leading agency tasked with enforcement, but they encourage collaboration with local agencies and local authorities. The new law would allow enforcement of the law through compliance checks.

By providing clearer guidelines for enforcement, AB 935 aims to reduce the availability of tobacco products, particularly to minors, and mitigate the associated health risks.
