SECOND AMENDMENT TO AGREEMENT 1820

THIS SECOND AMENDMENT TO AGREEMENT 1820 ("Amendment") is entered into effective July 1, 2017, by and between the County of Glenn ("County") and Stonycreek Garbage Service (Contractor).

RECITALS

The purpose of this Amendment is to modify the terms of Agreement 1820 ("Agreement") entered into between the County and Contractor on June 5, 2007, as set forth below.

AGREEMENT

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the parties hereto, each intending to be legally bound, covenant and agree as follows:

1. <u>Amendment to ARTICLE 3 of the Agreement</u>. ARTICLE 3 of the Agreement is amended in its entirety to read as follows:

The term of this Agreement shall commence on June 5, 2007 and shall terminate December 31, 2018. Thereafter, this Agreement may be extended for a successive one (1) year term upon written agreement of both parties.

2. <u>Continued Effect of the Franchise Agreement</u>. Except as expressly modified by this Amendment, the other terms and conditions of the Agreement, which is incorporated herein by this reference, shall remain in full force and effect and be binding to both parties.
