 - o A draft report and additional information is included in the Board meeting packet
- TNC/DWR Flood-MAR Multi-Benefit Recharge Project (no new updates)
- Well Monitoring Pilot Program
 - Developed an online application for a round 2 solicitation
 - Developed round 2 solicitation materials in conjunction with Consultant Team and CGA representatives
 - Distributed round 2 solicitation and reached out to round 1 applicants that were not selected to determine interest in participation (about 15 wells)
 - Landowner Agreement template for Round 2 was finalized and approved at the February Board meeting
 - Dependent of grant agreement amendment approval


New Conference Date, Annual Report, and more



COVID Sick Pay Returns

With the signing of SB114, COVID-19 sick pay is returning to California. This will take effect February 19th, but is retroactive to the first of the year. This bill will require employers with 26 or more employees to provide up to 80 hours of COVID sick pay to their employees, from the period of January 1-September 30th, 2022.

OSHA 300A Posting Reminder

Per OSHA injury and illness recordkeeping and reporting requirements, Tuesday, February 1, was the deadline to tabulate your annual OSHA Log Summary (OSHA Form 300A) and post it in a common area where notices to employees are usually posted. **This is the summary only (300A), not the OSHA 300 Form.** This must be posted where all employees may review, typically next to your Labor Law Posters from February 1 through April 30th, 2022.
