II. Approval of Minutes:

Andy Weinrich moved to approve the minutes for the December 16th, 2021, meeting. Seconded by Dan Kennedy, motion passed.

III. Agenda Items:

A. Public Comment: Jim Scolaro had questions for the OPMD regarding the use of GF120 and if it was required for those with olive trees. He has approximately 300 olives trees and pulls roughly 10% of his crop for personal use. Using sticky tape and monitoring them for Olive Fruit Fly, current impacts are drought and olive knot. Andy Weinrich spoke to the importance of all olive growers to care for their orchards. Noting there is no lawful requirement to spray, although canning industry has a zero tolerance for fruit fly damage. Dan Kennedy stated he continues to be a good steward in caring for his orchard. Bill Krueger mentioned that he found bottle traps worked well for fruit fly. Jim Scolaro mentioned that

trimming trees in the heat of summer was effective in treating olive knot and that within 10-14 days there was dry out.

Lisa Jones (Glenn County Ag Dept) mentioned Assistant Ag Commissioner Jason Beauchamp has not had any response from Dr. Israely since the virtual meeting was cancelled due to a lack of district member attendance for the scheduled meeting. Weinrich mentioned that perhaps the district itself should reach out to him. Weinrich then explained the interest in BioFeed and what efforts had been made so far.

C. Member Reports:

Krueger mentioned that having an open canopy prevents black scale and inquired about any active research going on. Weinrich mentioned the Olive Commission actively conducting research for both table and oil olives. Kennedy suggested OPMD contribute to other research in some capacity. Weinrich encouraged Krueger, with his knowledge and previous work experience, to share any ideas on what and where to conduct research.
