- 2. District members provided background/history to the establishment of the District and how the name "evolved" over time. Discussion ensued. Schonauer moved to update district documentation to reflect *Olive Fruit Pest Management District* as established in Resolution 2002-35 of the Glenn County Board of Supervisors, dated April 30, 2002.
- 3. Beauchamp updated the Directors on pending applications and the need for an additional member as established in Resolution 2002-35. Discussion ensued and possible candidates/partnerships were discussed.
- 4. Beauchamp mentioned and discussed the preliminary budget it will be on the agenda for the next District meeting.
- 5. There were no projects brought forward for consideration. Discussion ensued regarding the process of recommending projects and the procedure to act on those recommendations (action item).
- C. Member Reports:
  - 1. Kennedy brought up the District's involvement with research in the past and the shift within the olive oil and table olive industry encouraged the development of research ideas or involvement with ongoing industry projects.
  - 2. Weinrich discussed the concept of teaming up with our UC partners to develop an attract and kill trap. UC proposed a sterile insect release program during an olive industry meeting discussion ensued.
  - 3. Krueger discussed the need for another viable material, aside from GF-120. Mentioned being interested in understanding the effect of heat on the fruit fly.
  - 4. Additional discussion regarding the development of a time-release pesticide delivery system that could be employed in orchards of various types.

The meeting was adjourned at 9:24am.
