- 2. Maben announced the expiration of his district appointment on April 30, 2023, and requested a recommendation to reappoint. Kennedy provided the recommendation, Studybaker seconded, motion passed unanimously.
- 3. Maben requested district member nominations for the election of officers for the 2023-2024 fiscal year. Studybaker moved to elect Maben to Chair, Kennedy to Vice Chair, and Weinrich to Secretary; Maben seconded, motion passed unanimously.
- 4. Beauchamp introduced the preliminary budget, which the District Directors discussed and reviewed. Studybaker moved to adopt the preliminary budget, Weinrich seconded, motion passed unanimously.
