		have had their 1st petition. B.) Working on bringing Mobile Crisis to Glenn (CCMU), must be up
		and running by June 2024. C.) Looking for funding for a caged vehicle for staff going out on crisis
		calls. Tom A. recalls there may be some caged vehicles available and will discuss with Sheriff
		Gibbs. D.) Under AB 2275, when a client is detained on a 5150 hold at the ER, a hearing will be
		held within 7 days, conducted by a Hearing Officer. They will decide if the client will remain on
		the hold, or released. Client will be supported by the Patients' Rights Advocate to prep client for
		the hearing and represent the client. E.) SB 43 broadens the eligibility for conservatorship. Those
		experiencing serious mental health illness or server substance use disorders and most at-risk of
		harm to themselves can have a conservatorship appointed to direct their care. At the 12/5/23
		BOS meeting, the Board approved the extension for implementation of SB 43 to January 2026.
		We will be flying a recruitment for a volunteer Hearing Officer. F.) BH Bridge Housing – provides
		\$1.7m grant for temporary housing. Ca
		n be used to support housing for CARE Court population. Exploring the idea of purchasing a
		building to expand capacity for existing Board & Care clients, crisis stabilization.
