Other Violations (continued)

- 16) Require all other employees to obtain food handler cards and maintain copies available for review. Facility has 10 employees but only had 2 food handler cards available.
- 21) Provide warm water at 100°F at handwash sink by front service line. Hot water handle is inoperative.
- 30) Cease storing food items (peppers) on floor.
- 15) Clean dough from under block wall by ~~up~~ dough prep table.

Note: wall may not be smooth & cleanable. If issue persists, our department will require wall to be resurfaced.
