

Emergency Solutions Grants Program – Coronavirus Round 2 (ESG-CV2)

Request for Funds (RFF) Application

Introduction

The California Department of Housing and Community Development announced the availability of approximately \$42 million in federal funds for the Emergency Solutions Grants program (ESG), funded and regulated under the Coronavirus Aid, Relief and Economic Stimulus (CARES) Act, referred to as ESG-CV1. Following this, an additional round of funding totaling approximately \$253 million was announced, referred to as ESG-CV2 (Emergency Solutions Grants Program, Coronavirus Round 2). The purpose of ESG-CV2 funding is to prevent, prepare for, and respond to coronavirus among individuals and families who are experiencing homelessness or receiving homeless assistance and to support additional homeless assistance activities to mitigate the impacts created by coronavirus.

Funding Available

The Dos Rios Continuum of Care (CoC) region serves Colusa, Glenn, and Trinity Counties. The Dos Rios CoC has received an award of \$90,000.00. This solicitation is for entities interested in offering program services under this funding opportunity. Applicants may be public or nonprofit agencies that provide services to prevent, reduce, and end homelessness, and are active members of the Dos Rios CoC.

Each applicant requesting funding is eligible to request a maximum of \$29,033.33. Each County within the Dos Rios CoC shall each receive a maximum total allocation of \$29,033.33. Coordination within the local County jurisdiction is encouraged. There is no matching contribution requirement for activities. Providers/ agencies selected to receive funding will be required to enter in a subrecipient agreement and expend all funding by September 30, 2022.

Application Process and Instructions

The ESG-CV2 Application will be submitted to the approved Administrative Entity (AE) for the Dos Rios CoC, the Colusa-Glenn-Trinity Community Action Partnership through the Glenn County Community Action Department.
