 Fahey requesting the CGA Executive Committee review and provide comments.

 - It is likely that a Joint Executive Committee meeting will take place to discuss the MOU (timeline currently unknown).
 - Following CGA and GGA Executive Committee reviews, the draft will be brought to both Boards for review, comment, and consideration of approval.
- Long-Term Funding
 - Continued coordination with Provost & Pritchard staff, the County's Department of Finance, and Counsel to complete necessary tasks to have the assessment be placed on the 2019/2020 tax roll.
 - Additional updates will be given under a separate agenda item.


