COMPONENT PROPOSAL NARRATIVE

1. Framework and Goal Support

Briefly describe: 1) how the County plans to use Capital Facilities and/or Technological Needs Component funds to support the programs, services, and goals implemented through the MHSA, and 2) how you derived the proposed distribution of funds below.

Proposed distribution of funds: Allocation \$788,500

Capital Facilities \$360,500 Technological Needs \$428,000

The Capital Facilities funds will provide the opportunity to develop our facilities to better meet the service needs of our clients. With these funds, we plan to purchase a modular building for service provision and office space in Orland. This Capital Facilities Project fully supports our MHSA goals and objectives to improve access for unserved and underserved clients, make services more welcoming to promote wellness and recovery, and achieve optimal outcomes.

The Technological Needs funds will help support our implementation of an electronic client record through the purchase of a new server, expanded IT network, and clinical desktop software. This Technological Needs Project supports our MSHA activities by creating a secure network which ensures client confidentiality and creates the capacity for an electronic clinical record. This project will minimize paperwork and maximize staff time for service delivery to our clients, promoting resiliency, wellness, and recovery so that clients achieve positive outcomes.

The proposed distribution of funds is 45% for Capital Facilities and 55% for Technological Needs. This distribution was determined by reviewing the input from our stakeholder survey, holding stakeholder focus groups, examining the priorities of our MHSA program, and outlining the costs of each component. The final determination was made to ensure equitable distribution and access to the funds, as well as the development of projects that maximize the limited resources for this small, rural county. Each project will be briefly described below.

Capital Facilities

Orland Facility Project: Purchase modular building for mental health services in Orland

Capital Facilities funds will be dedicated to purchasing a modular building that will be placed on existing, county-owned property in Orland, the county seat. This property currently has a county-owned building and parking lot, which houses our CRC program. The CRC program offers service for clients who have co-occurring disorders (mental health and substance abuse). The modular building will be placed behind the CRC building and will create office space and meeting rooms for mental health staff who serve all ages, including children, Transition Age Youth, adults, and older adults. In addition, psychiatric services for all age groups will be available. Staff are currently located in a building which is leased by the county. By purchasing this modular, we avoid rental fees and create more cost-effective services.

Glenn County Health Services Agency

Through co-location with CRC, we will also provide better linkages to those clients and families who need substance abuse services, or have co-occurring disorders. This linkage will be especially valuable for those Transition Age Youth who have co-occurring disorders. The reception area for the new building program will be placed within the existing county-owned building to improve access to services for clients, creating a welcoming, comfortable environment for clients and their families.

Technological Needs

<u>IT Infrastructure Upgrade Project</u>: Purchase and install new servers, storage, backup equipment, and clinical desktop software

The Technological Needs funding will be used to purchase new servers for each location, storage, and backup of files capacity, and cover installation costs to ensure secure clinical records. These upgrades will expedite staff access to client information and share critical information for high-risk clients (e.g., allergies, drug sensitivities, recent crisis information, as appropriate). The electronic clinical record will also reduce staff time in pulling and filing charts, keeping all information available on the server. The new server and equipment will also ensure the security and privacy of protected health information by having state-of-the-art equipment and software.

We will also purchase software to allow clinicians to document all services in an electronic clinical chart. The development of an electronic clinical record will help streamline assessments, document services, and track outcomes over time. This system will also help monitor due dates for charting, client service plans, and other utilization review activities.

2. Stakeholder Involvement

The Glenn County Capital Facilities and Technological Needs (CFTN) planning process continued the comprehensive work of our earlier MHSA planning efforts by utilizing our excellent partnership with consumers, family members, staff, and community stakeholders. Input on the CFTN component was obtained through a variety of sources, including two CFTN surveys, our monthly MHSA Executive Leadership Team meetings, our monthly MHSA Consumer meetings, Children's Interagency Coordinating Council meetings, Management and Planning Team meetings, Advisory Board meetings, and individual communications with clients and family members. Meetings and focus groups included representation from traditionally unserved and underserved populations, including Transition Age Youth, Latinos, Native Americans, and older adults; there was extensive consumer and family member participation as well.

We developed two surveys that provided staff, volunteers, and consumers the opportunity to give feedback on capital facilities and technology needs. One survey focused on Capital Facilities issues; the other addressed Technological Needs. The surveys were distributed to persons throughout the county. Over 225 surveys were completed.

The MHSA Executive Leadership Team, comprised of consumers, family members, staff, and other stakeholders reviewed and discussed the results of the two CFTN surveys. The Team used these tools and additional input from key stakeholders to determine the highest priorities for Capital Facilities and Technology Projects. Input from these planning activities were compiled and developed into the core components of the Capital Facilities and Technological Needs Component Proposal.

<u>Public Review and Comment Period</u>: A draft of the CFTN Component Proposal has been posted on our website for 30 days from April 20, 2009 through May 20, 2009. The CFTN Component Proposal is available on the Glenn County website. The Proposal has also been distributed across the county and placed with allied agencies, at the courthouse, and at public libraries.

<u>Public Hearing</u>: A public hearing will be held on Wednesday, May 20, 2009 from 10:30 am – 12:00 noon at Harmony House (343 Yolo Street, Orland, CA). Input on the CFTN Component Proposal will be reviewed and incorporated into the final document, as appropriate, prior to submission to DMH for approval.
