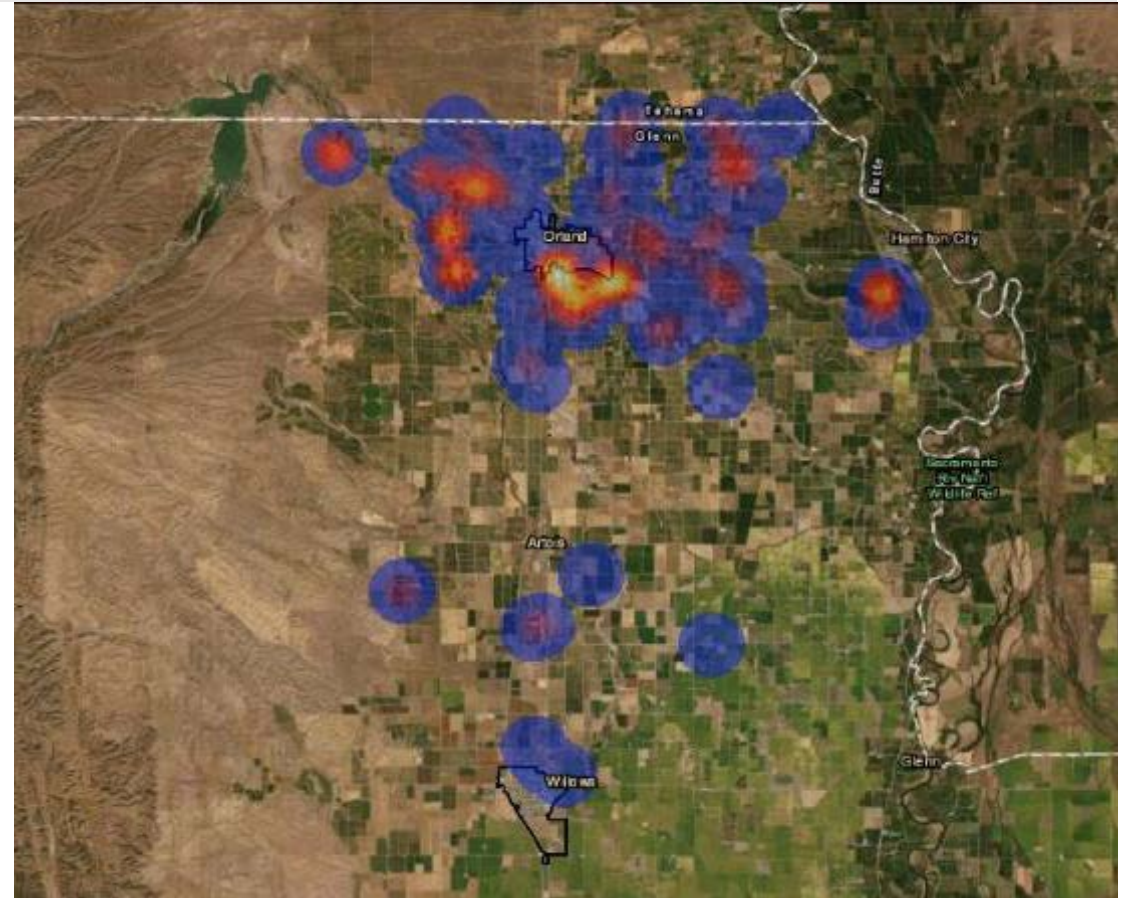


# Glenn County Drought Status



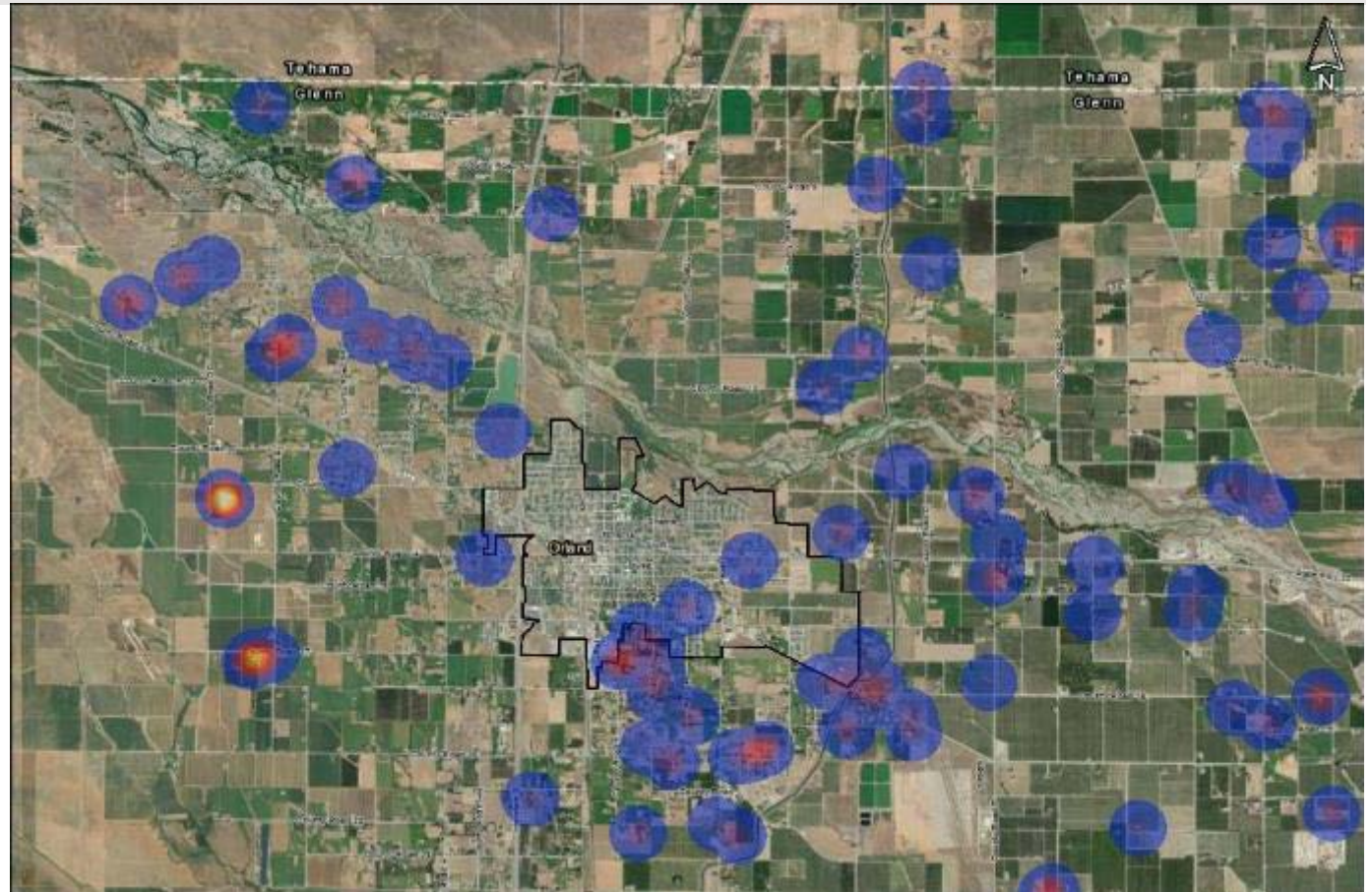
# Glenn County Heat Map

- One of the hardest areas hit by current drought
- 155 dry wells in Glenn County
- 67 additional wells with water supply issues



# Orland Area Heat Map

- 66 dry wells in and around Orland Area
  - 33 additional wells with water supply issues

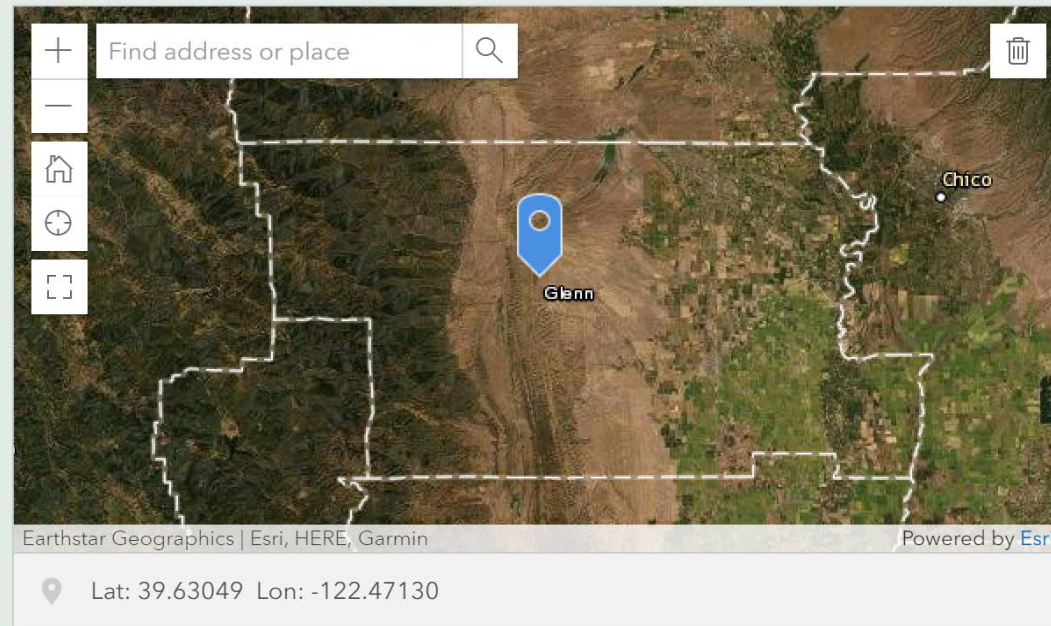

# Emergency Drought Funding

- Authorized by the Legislature Pursuant to the Budget Act of 2021 (Stats. 2021, ch. 240, §80) and its Trailer Bill, (Wat. Code, § 13198 et seq)
  - \$200 million for **Small Community Drought Relief Program**
  - Small Communities not served by urban water systems eligible



# Glenn County Approved Funding

- Glenn County Hauled Water Project - **\$1,878,322**
  - Provide immediate relief up to 12 months:
    - ❖ Hauled water
    - ❖ Bottled water
- Orland Emergency Groundwater Resource Project - **\$7,735,000**
  - Provide long-term solution:
    - ❖ Construct a new well with a storage tank
    - ❖ Connect the new well to the existing water system
    - ❖ Provide home connections



# Partners

- California Department of Water Resources (DWR) is partnering with:
  - State Water Resources Control Board (SWRCB)
  - Glenn County (County)
  - City of Orland (City)
  - North Valley Community Foundation (NVCF)



# Long-Term Solution

- Connecting to City of Orland Water Supply System
- Expand and extend water distribution system
- Connect everyone interested
- Priority based on dry wells reported

# Short-Term Solution

- Drinking Water Delivery
- Temporary Tank and Pump Installation
- Hauled Non-Potable Water Delivery





# Drinking Water Delivery

- **How to receive this water?**
  - Information Line – (530) 230-4153
  - Complete Agreement with NVCF
- **How much water can a family receive?**
  - 60 gallons per month per household
- **How frequently can they receive?**
  - Based on contractor's delivery schedule
- **How long can they receive this water?**
  - One year



# Temporary Tank and Pump Installation

- **How to receive this water?**
  - Information Line – (530) 230-4153
  - Complete Agreement with NVCF
- **NVCF will provide vendors with clearance/information**
- **Vendors will call you with delivery/installation information**



# Hauled Non-Potable Water Delivery

- **How to receive this water?**
  - Information Line – (530) 230-4153
  - Complete Agreement with NVCF
- **How much water can a family receive?**
  - 1,250 gallons per address per delivery
- **How frequently can they receive?**
  - Two deliveries per month
- **How long can they receive this water?**
  - One year

# FAQs

- **Who can we connect?**
  - Dry Well Households
  - Other Households based on Project alignment
- **Do we need to pay fees to connect?**
  - Free – most cases
- **What is included in the Project?**
  - Water Mains
  - Connections to households (most homes)
  - Water Meter
  - Back Flow Preventer



# FAQs

- **Do we need to abandon our well?**
  - No, but Back Flow Preventer is required
    - \$48 per year fee
    - removed after abandonment of well
- **Do we need to Annex to the City?**
  - Not expected or anticipated at this time
- **How do we sign up?**
