	Glenn County Redistricting was approved yesterday. Drought persists with dry well reports continuing Grant assistance programs are underway.	

• EMS and LEMSA:

Vickie Pinette, SSV/LEMSA

- System Reports are posted online on the SSV website. GC Response Times Report will be sent out with the minutes.
- Butte County is going to the RP (request for proposal) process for ambulance service. The process will start in January and expect to be completed around June 2023.

Enloe Ambulance- Mark Walker

- Still experiencing staffing issues/shortage of paramedics.
- Two new ambulances were received yesterday, will be deployed in approximately 1 month.

• OES/Law:

Amy Travis, OES

- GC October Storms Local Emergency terminated yesterday.
- OES Recovery Team performed a site assessment for damage to County Roads 309, 313, and FH7.
- Requested assistance from Cal-OES for \$100,000 in damages and response costs; claim is under evaluation. It is anticipated that a determination will be provided in a few weeks.
- Emergency Management Performance Grant (EMPG)
- Extra \$60,000 awarded this year; Projects to include partnering with GC Planning Department GIS purchasing equipment and working with them on GIS mapping of evacuation zones; purchasing a cache of portable radios; air mast and antenna for OES command trailer.
- Ian Ledbetter stated that CUPA can assist with evacuation zones and outreach to the community so people know what zone they are in.
 - Homeland Security Grant Program (HSGP)
- The group of five met this morning to review status of projects in grant years 2019-21 and to select the projects to be included in the 2022 grant application. Projects include:
- Orland PD Surveillance and Key Card system
- SERT Team at GCSO (Helmets, vests, etc)
- Radios for Baylis Fire and Hamilton City Fire
- Automated CPR device for Willows Fire
 - An additional \$100,000 + was awarded to Glenn County under Fiscal Year 2021 for Cybersecurity projects.
 - Unified Dispatch for Law/Fire project is underway with a target implementation date of January 2023
 - OES/SAR (Search and Rescue) Exercise was conducted on November 6, 2021. The exercise tested command, communications, ICS structure, and search and recovery operations. Numerous response assets were deployed including the OES Command trailer and the portable repeater.

• Cal OES has been focused on fire recovery and storm damage recovery (Glenn County.)

- Unified Dispatch means all FD will be on the same frequency and delays in information will be shortened. Estimated for January 2023.
- Working on several grants with a grant writer (USDA \$275,000 towards new Type 1 Engine; regional grants for SCBA's; Cal Fire grant (Stony Creek mitigation).
