## **RESOLUTION 2021-032**

## A RESOLUTION OF THE GLENN COUNTY BOARD OF SUPERVISORS PROCLAIMING A LOCAL EMERGENCY DUE TO DROUGHT CONDITIONS IN GLENN COUNTY

WHEREAS, rainfall totals and water storage supply have been critically low; and

**WHEREAS,** extraordinarily warm temperatures in April and May have worsened this critically dry year for the State of California, accelerating snow melt in the Sacramento, Feather and American River watersheds, reducing expected water supplies by more than 500,000-acre feet; and

**WHEREAS**, on March 5, 2021, the Secretary of the United States Department of Agriculture designated California's 58 counties as a primary natural disaster area due to recent drought; and

*WHEREAS,* on May 10, 2021 the Governor of the State of California proclaimed a drought State of Emergency in 41 Counties; and

**WHEREAS**, the drought poses significant economic, environmental, health, welfare and social impacts and an imminent threat of disaster to the County's citizens, businesses, agriculture, property, communities, environment, wildlife and recreation; and

NOW, THEREFORE, BE IT RESOLVED, ORDERED AND PROCLAIMED BY THE GLENN COUNTY BOARD OF SUPERVISORS, pursuant to Government Code Sections 8558 and 8630, that Glenn County is a disaster area and that a local emergency exists throughout Glenn County; and

IT IS REQUESTED that the Governor of the State of California waive regulations that may hinder response and recovery efforts, make available California Disaster Assistance Act funding for the State of Emergency proclaimed on May 10, 2021 and seek all available forms of federal disaster assistance and relief programs, including a Presidential Declaration of Disaster; and

IT IS FURTHER PROCLAIMED AND ORDERED, that a copy of this resolution be forwarded to the Director of the State Office of Emergency of Emergency Services and all State and Federal legislators representing the County of Glenn.
