II. Approval of Minutes:

A motion was made by Dan Kennedy and it was seconded by Andy Weinrich to approve the March 31, 2015 as is. All present were in agreement.

III. Agenda Items:

A. **Public Comment**-there was no comments from the public.

B. Discussion and/or Action Items:

1. Authorization of Signatures Form-Tina Brothers mentioned that the form needs to be updated on an annual basis so it was determined by a vote to have all the directors authorized to sign claims and transfer of funds forms effective December 5, 2015. A motion was made by Dan Kennedy and it was seconded by Andy Weinrich. All present were in agreement.
2. Olive Fruit Fly Count Update-The spreadsheet for the hot spot areas in the county was passed out for review. Dottie trapped until November 5, 2015. The fly count never really went down and Ernie mentioned that he put the Attract & Kill traps in the locations that showed really high fly

counts at the beginning of the season. Ernie passed out the UCCE Olive Fruit Fly count totals for the Glenn and Tehama project for review.

Dani Lightle mentioned that the Attract & Kill traps are no longer available to purchase however if you still have some on hand you are able to use them. The manufacture is looking into registering another trap but it won't be available until 2019. Ernie mentioned that he doesn't have any more for Glenn County.

Andy mentioned using Danitol on the roadside trees however Dani mentioned that it's a contact kill spray so you would need to spray it on a regular basis. Andy would like to look into a SLN for Danitol so he volunteered to discuss this with the Glenn County Agricultural Commissioner.

Ernie suggested using the sticky traps in the City of Orland to monitor the Olive Fruit Fly. He will need 400 traps. A motion was made by Dan Kennedy and it was seconded by Russell Maben to purchase 400 traps. All present were in agreement.

3. Roadside Spraying Update-Ernie informed the District that he sprayed March 2015 to October 2015 totaling 6 applications to the entire county using 75 gallons of GF120. He also mentioned that he placed 1260 Attract & Kill traps in the Orland Area from March to April 2015.
4. GF120 Update-Tina informed the directors that Simplot was awarded the 2016 bid for the amount of \$132.55 per gallon including tax. Ernie mentioned that he still has about 15 gallons so he would need to purchase 60 gallons for the season. Dan Kennedy made a motion to have Ernie purchase the 60 gallons and it was seconded by Andy Weinrich. All present were in agreement.
5. Tree Removal Projects-Ernie mentioned that Charles Embrey had 11 trees that were very large and he figured it would cost \$2,000.00 to remove them. Ernie got a bid of \$1,800.00 from Lalo's Tree Service. Ernie also mentioned that he talked to Dalene Shippelhoute about removing her twelve trees. She told Ernie she needed to talk to her son and would get back to him. Dan Kennedy made a motion not to exceed \$1,800.00 to remove Charles Embrey's trees and it was seconded by Andy Weinrich. All present were in agreement.
6. Review Bylaws, Food & AG Code and Resolution-Tina handed out the Bylaws, Food & AG Code and Resolution so the new directors could review the procedures of how the District operates.
