Glenn County COVID-19 Update

GLENN COUNTY, CA — On Wednesday April 28, 2021, Glenn County will move from Tier 2 (Red) to a less-restrictive Tier 3 (Orange) of the State's COVID-19 Blueprint for a Safer Economy. The California Department of Public Health (CDPH) and the Western States Scientific Safety Review Workgroup supports the recommendation of the FDA and CDC to lift the pause on the vaccine. Clinics in California may begin administering the Johnson & Johnson vaccine immediately as long as appropriate educational materials are provided to inform patients of the vaccine's low risk of associated health effects and other available vaccine options. Glenn County vaccine providers will continue to provide Johnson & Johnson vaccine as an option to residents. To find more information including the new fact sheet, visit:

According to the California Department of Public Health (CDPH) data on vaccine coverage, 42% of Glenn County's eligible population has had at least one dose, 32% are fully vaccinated, and 10% are partially vaccinated. Although, Glenn County's coverage is lower than the State's average (57.9% with at least one dose), its vaccine coverage is similar to other counties in our region of northern California.
