CalFresh Update and Local Resources Available for Glenn County Residents Amid Federal Shutdown

Glenn County, CA—The Glenn County Health and Human Services Agency (HHSA) is closely monitoring the impact of the federal government shutdown on CalFresh benefits. At this time, approximately 4,521 Glenn County households receiving CalFresh may experience changes or delays in benefit issuance, depending on the length of the shutdown.

We encourage residents to continue applying for CalFresh. Applications are still being accepted, processed, and evaluated for eligibility. New applicants may still qualify for benefits that will become available once the shutdown ceases.

In addition, we want to reassure our community that the HHSA Public Health's Women, Infants, and Children (WIC) program is fully operational at this time. Participants are encouraged to continue using their food benefits, and applications are being accepted for eligible families.

"We believe that access to food and nutrition is an undeniable basic need and know many of our CalFresh customers need extra support at this time," said Laura Hawkins, HHSA Director. "We want to assure our community of our commitment to providing guidance and connecting individuals to vital resources during this time of uncertainty."
