The Behavioral Health Clinician I/II performs a variety of professional duties in the provision of outpatient and crisis behavioral health services to individuals and groups. This position will provide services utilizing the Wellness and Recovery philosophy and values, which include consumer and/or family-driven planning. The position is scheduled for forty (40) hours per week.

THE IDEAL CANDIDATE

The ideal candidate will be licensed as a Clinical Social Worker or Marriage Family Therapist. This person will be able to establish and maintain cooperative working relationships with those contacted in the course of work.

JOB DUTIES

- Provides professional mental health outpatient evaluation, consultation, and treatment services to individuals and groups.
- Performs client intake procedures.
- Provides individual, group, and family counseling on a variety of mental health problems and substance use disorders; develops treatment plans; provides follow-up counseling and assists patients with the resolution of problems.
- Observes patients on-site at schools, etc., as necessary; conducts home visits as necessary. Consults with psychiatrist and other clinical staff about treatment planning for clients.
- Provides psychotherapy to children and adult clients or their relatives through individual or group therapy methods.
- Performs performance outcome measures and completes related administrative work.
