THE SELECTION

PROCESS

Candidates must submit a completed job application. Application packets will be screened and candidates considered best qualified will move forward to a competitive examination process, which may include a written exam, practical skills exam, an oral interview, fingerprinting/background check or medical examination process if applicable. Eligible lists are used for Full-Time (40 hrs./wk. with benefits), Part-Time (20-39 hrs./wk. with benefits), and Public Service employee (PSE) temporary (limited benefits).

THE POSITION

The Public Service Worker II—PW performs a variety of semi-skilled and skilled labor in the construction, maintenance and repair of county roads, bridges, culverts and other related structures, and in various traffic control maintenance and repair activities or in the various solid waste site activities of the Public Works Agency; to operate a variety of construction, maintenance and transportation equipment as necessary to complete daily tasks. This position is at-will, temporary scheduled for twenty-five (25) to forty (40) hours per week, up to 960 hours in a fiscal year.

THE IDEAL CANDIDATE

The ideal candidate will have experience in the construction trades or road maintenance.

WHAT YOU'LL DO

- Prepares roads for patch repairs, overlays, or chip seals; prepares mix for patching roads; repairs and reconstructs roads.
- Forms, pours, and finishes concrete.
- Prunes trees and other vegetation as needed.
- Cleans roadsides and drainage systems; inspects and clears debris from drainage systems; conducts roadside burning as needed.
- Removes snow and ice from roads in inclement weather; removes mud/debris resulting from mud slides.
- Hauls materials to and from work sites as required.
- Directs and controls traffic around work sites.
- Installs and repairs sign posts and signs; installs and replaces road markers; maintains records on road sign vandalism, sign replacement and new sign installation.

About Glenn County Glenn County has a population of 29,132 and is located mid-way between Sacramento and Redding in Northern California. Glenn County is primarily an agricultural community with mountains on the west, the Sacramento River bounding the east side and the Interstate 5 corridor taking you through the rich farm land of the County. With over 1,188 farms, agriculture remains the primary source of Glenn County's economy. Major commodities include rice, almonds, milk products, prunes, bees and livestock.
