What did you Miss? Key Takeaways from the September EP HCC Meeting:


The Butte County Public Health Lab seeks to expand this season's respiratory outlook by analyzing Flu, RSV, and COVID-19 lab samples. Please reach out to the Butte Lab to work with providing specimens so community surveillance can be conducted. The lab will provide test kits, limited courier services, and accept samples from both Butte and Glenn County facilities. It is in the community's best interest to know what is circulating out there!

Orchard Hospital is now part of American Advanced Management (AAM) and their CEO is Steve Stark, who is managing Orchard along with Glenn and Colusa Medical Centers. Welcome to the Butte-Glenn EP HCC!

Weather Outlook

The North American Multi-Model Ensemble (NMME) is predicting for October, November, and December that the average temperature will be 0.45 to 3.6°F (0.25 to 2°C) above normal. The NMME integrates multiple forecasts of the next 90 days to build the best estimate of temperatures and precipitation over the time frame.

According to the National Oceanic and Atmospheric Administration (NOAA) there is an 84% chance of greater than a moderate strength El Nino, and a 56% chance of a strong El Nino developing. This means we should all be prepared for another wet winter! Fall is the perfect time for every facility to be working on getting "Winter Ready". If your facility needs any help winterizing please let either Butte or Glenn Public Health Departments know!

Feather River Tribal Health



Feather River Tribal Health (FRTH) provides comprehensive care to Native American and non-native registered patients. FRTH has a holistic healthcare approach that minimizes the need for patient referrals by offering a comprehensive range of services. During a recent interview with incoming CEO Eric Lyon, retiring CEO Maria Hunzeker, and Dean Strait, RN, Wellness Director they discussed furthering patient well-being with their expanded services and dedication to accessible healthcare. FRTH serves approximately 5,800 patients across Butte, Yuba, and Sutter counties.

An exciting new addition to FRTH's services is the drive-thru prescription option for patients. FRTH has also begun a low-dose induction program using Suboxone to address vital substance abuse treatment needs within our community. Another addition is the provision of holistic specialty care services in their Wellness Center, which focuses on preventative patient services such as chiropractic, yoga, nutrition, and physical therapy. These new services truly underscore FRTH's commitment to an all-encompassing approach to healthcare.



FRTH & Strategic Preparedness

FRTH endorses strategic preparedness by maintaining an inventory of medical supplies, surge tents, and a mobile medical unit for future emergencies and disasters. The Wellness Center has played a crucial role in providing temporary housing for staff during the 2018 Camp Fire. FRTH expresses a community-centric approach in sustainability initiatives and training events with the HCC to promote staff safety and preparedness. Their dedication to accessible, holistic healthcare and community well-being sets a strong foundation for continued success.

Emergency Preparedness Tips



Winter Weather

Be prepared for winter weather at home, work, and in your car. Create an emergency supply kit for your car. Include jumper cables, sand, a flashlight, warm clothes, blankets, bottled water, and non-perishable snacks. Keep a full tank of gas.

Prepare your facility to keep out the cold with insulation, caulking, and weather stripping. Learn how to keep pipes from freezing. Install and test smoke alarms and carbon monoxide detectors with battery backups. Gather supplies in case you need to shelter in place for several days without power.



Preparing for a Flood

Make a plan for your facility, including any animals, so that you know what to do, where to go, and what you will need to protect yourselves from flooding. Learn and practice evacuation routes, shelter plans, and flash flood response. Gather supplies, including nonperishable foods, cleaning supplies, and water for several days in case you must leave immediately or if services are cut off in your area.

Other preparedness efforts you can make; keep important documents in a waterproof container, create password-protected digital copies, move valuables to higher levels, declutter drains and gutters, install check valves, and consider a sump pump with a battery.

Remember to enroll in community emergency alerting programs like NIXI F and CodeRFD.

When preparing for disaster,

When preparing for disaster, considerations for the whole community should include accessible transportation options, medical needs, and keeping individuals connected with their families, personal care providers, essential equipment and technologies, and service animals are important. Proper planning is essential to successful disaster response.
