# **YOUTH QUEST 2022**





After two years of virtual conferences, our SWAT youth were able to attend CYAN's annual Youth Quest event in Sacramento. This was a great opportunity for them to learn about the environmental impact that commercial tobacco has in our communities. The youth had the opportunity to advocate for their local community by meeting with Assemblymember Gallagher's legislative aid. During that legislative visit, our youth shared their local efforts to combat the harmful effects of tobacco in our community.



Companies are creating inhalable products that are marketed as wellness products. They claim to be healthy because they contain vitamins or essential oils.

These products can be **dangerous** as some contain flavorings and have not undergone toxicity or clinical effectiveness evaluations. Essential oils are known to be used for aromatherapy, but when inhaled directly at larger doses it can result in **toxicity**. Beware of these products!



On March 15th, a bill was passed that authorizes the FDA to regulate synthetic nicotine.

The bill includes a provision amending the definition of a "tobacco product," which will now be defined as "any product made or derived from tobacco, or containing nicotine from any source, that is intended for human consumption." This law became effective on April 14th, and any synthetic nicotine product can remain on the market for an additional 30 days, but after that date, it will need to be approved by the FDA. After July 13th, 2022, any synthetic nicotine product not authorized must come off the market and will be subject to enforcement by the FDA.
