The Following is Addendum 3 to the Request for Proposals (RFP) for the County Road 35 at Walker Creek Bridge Project. Please acknowledge receipt of this addendum on your submission.

QUESTIONS RECEIVED

1. Can you please clarify if your responses to Questions 1-4 (provided in Addendum #2) are specifically related to the Site Restoration Plan scope? Please see our submitted Questions 1-4 below:
 - Q1 | For development of the plans, specifications and estimate (PSE), will there be 3rd party reviews (e.g. resource agencies or Caltrans) that may require multiple submittals?
 - Q2 | Is the intent for timeline of the Site Restoration Project PSE to be bid for construction concurrently with the bridge replace (e.g. part of the bridge project), or will it be bid separately?
 - Q3 | If bid separately, the timeline in Padre Associates Site Restoration plan states that the planting will be conducted in October-December following completion of the bridge replacement. Is the intent for planting to be completed in October-December 2026?
 - Q4 | Does the County wish cost proposal include cost for a 5-year monitoring program referenced in Padre Associates report?

A: Questions 1-3 pertain to the Site Restoration Project. This work will be completed by a contractor hired specifically to do the site restoration, and not part of the bridge construction contract. Question 4 is pertaining to the Consultant. The County is requesting the Consultant provide construction engineering (CE) services for the Bridge Construction Project and also provide preliminary engineering (PE) and construction engineering (CE) services for the Site Restoration Project. The 5-year monitoring of the restoration is to be included in that scope of services.

2. Are we allowed to include any proposed contract revisions in an Appendix so they do not count against page limitations?
