Housing Element Update

The Housing Element is required under California law to identify and analyze existing and projected housing needs, in order to preserve, improve, and develop housing, as well as demonstrate how the County accommodates its share of the regional housing needs.

Housing Element Definitions need are being added to the update of the Glenn County Unified Development Code. Annual Housing Progress Report in process, to do by April 1.

Mitigation Monitoring

Review, correspondence, and inspections regarding all past Conditional Use Permits, Mitigations, and Conditions of Approval.

Conditions of Approval and Mitigation Measures are being reviewed and monitored for completion and compliance. Also reviewing Parcel Divisions for recordation/expiration.

Surface Mining and Reclamation Act (SMARA)

Authorizes and directs local agencies to adopt ordinances and establish procedures for the review and approval of mine reclamation plans and the issuance of mining permits.

Review/Update of Financial Assurance Estimates and Mechanisms.
Assisting operators, and State Department of Mine Reclamation,
with procedures and general SMARA questions.
Mine Inspection completed; reports to do.

Glenn County Safety Element/Hazard Mitigation Plan update - Cal-Fire Grant

Glenn County received CalFire's Climate Investment Grant in order to fund the update of the Safety Element of the General Plan.

The grant amended to complete an updated Hazard Mitigation Plan. Staff is reviewing the Draft MJHMP Update for submittal to CalOES/FEMA.

Glenn County Small Business Assistance Grants

ARPA grants available to non-profits impacted by COVID-19; the grant is amended to infrastructure.

Numerous non-profit grant review and dispersals continue. Administration working with Cities for on ground improvements.

Glenn County Drought Resilience Plan Grant
